Do It Right the 1st Time

Here are guidelines to help you get your travel voucher processed quickly. If your submitted voucher is lacking an item or missing something, the voucher will be returned to you in its entirety, you will need to make the correction and send everything back.

You will find the reimbursement form for FY 2019 attached, do not use any other forms.
DO NOT FORGET to add your receipt for air/train travel or if you drove, you will need to include the approved cost comparison form.
The lack of receipts will delay processing. You will not be reimbursed tips on any type of transportation/housekeeping/concierge items. If it is included, your travel voucher will be sent back for correction.
All mileage claimed will require a Google map. Please do not use your actual address. You may use the street name, avoid giving the processing center your physical address unless you work from an office.
The maximum allowable reimbursement for <u>airport</u> parking is \$50.00, as of right now there is <u>not</u> a restriction on hotel parking.
Your name must be on top of the form and a "wet" signature on the bottom.
Please complete your form, sign the document, add your receipts and scan into a PDF document. If you can put your receipts and voucher in one PDF document, it does simplify the processing of your claim however it is not required.
Avoid sending your reimbursement to multiple emails, use the following email statereimbursements@ncua.gov for speedier processing.
If anything has changed in the way you bank, you will need to complete another ACH form.
